**MirLand Development Corporation plc**

("MirLand" or the "Company")

**Notification of Interests**

MirLand, one of Russia's leading residential and commercial property developers, announces that it was notified on 8 January 2014 that, on 23 December 2013 and 7 January 2014, Darban Investments Ltd ("**Darban**") (a company controlled by Mr Eliezer Fishman, a non-executive director of the Company) purchased 6,920 ordinary shares of MirLand at an average price of £2.40 per ordinary share.

Following this transaction, Darban is interested in 15,453,852 ordinary shares in the Company, representing approximately 14.92% of the Company's entire issued share capital.

Mr Eyal Fishman, a non-executive director of the Company, holds a 15.8% equity interest in two companies which, through various intermediate companies, hold an effective interest of approximately 76.9% of Jerusalem Economy Ltd. ("**JEC**"), which holds a legal and beneficial interest in approximately 30.47% of the Company.

Mr Eliezer Fishman and his wife Tova Fishman together hold approximately 53% of the intermediate companies referred to above and which hold an effective interest of approximately 76.9% of JEC.

Darban, together with JEC and Industrial Buildings Corporation Ltd (a company controlled by Mr Eliezer Fishman), effectively hold a legal and beneficial interest in approximately 85.9% of the Company's entire issued share capital.
